APPRENTICESHIP OPPORTUNITIES

This program is registered with the Oregon State Apprenticeship Training Council and is recognized by the Bureau of Labor and Industries. Applications will be accepted for the following trade:

PLUMBER – Non Union

Minimum Qualifications:

1. Eighteen (18) years of age.
2. High school graduate or General Education Development Certificate of Equivalency.
3. One year of high school Algebra I or Integrated Math 2 with an average yearly grade of “C” or better. A college Algebra course that meets or exceeds high school Algebra, with a grade of “C” or better may be substituted for high school Algebra. A college math placement test indicating placement in Math 60 or higher may also be substituted for high school Algebra.

Note: Applicants must submit non-returnable proof of age AND high school transcripts or GED certificate. Applications and documentation (items 1-3 above) **must be received by the closing date, according to the following schedule.**

General Duties of a Plumber: Assemble, install, alter and repair pipelines or pipe systems that carry water, steam, air, or other liquids or gases. May install heating and cooling equipment and mechanical control systems.

RANKING SYSTEM POINTS:

Applicants who do not qualify for direct entry will be placed in the RANKED POOL, in descending order, based upon the number of points scored. Applicants can earn points for education related to the occupation, and also for work experience.

- To receive points for classes Applicants must provide course certificates or school transcripts.
- To receive points for work history Applicants must provide documentation of work hours (W-2, letter from employers with documented work, DD-214, or work history print-out from the State of Employment Division).

ALL DOCUMENTATION MUST BE RECEIVED BY THE CLOSING DATE ON THE OPENING ANNOUNCEMENT.

*One Year = 2,000 hours. Three (3) is the maximum number of years of experience that will be credited in any work experience categories. All points will be supported with documentation provided by the applicant.

Documentation you need to submit with your application:

- Diploma or GED
- High School / College Transcripts
 - College Placement test results showing at least a 60 in Math *if* you did not take/pass Algebra I or Integrated Math 2 with at least a C in High School
- Resume
- Proof of employment for 3 years of jobs on resume
 - Paystubs or W-2s (if emailed please black out SSN)
 - ~or~ Letter on company letter head stating that you worked for the company from date to date and basic job description

Once all applications and documents are in, we will determine each applicant’s points. The submitted documents will determine your points, if in doubt submit it and we will either allow or not, but better to submit and not be able to use it, rather than not submit and find you missed out on points.

Each complaint filed must be made in writing and include the following information:

- (a) Complaint's name, address, and telephone number, or other means for contacting the complaint.
- (b) The identity of the respondent (i.e. the name, address, and telephone number of the individual or entity that the complaint alleges is responsible for the discrimination);
- (c) A short description of the events that the complaint believes were discriminatory, including but not limited to when the events took place, what occurred, and why the complaint believes the actions were discriminatory (for example, because of his/her race, color, religion, sex, sexual orientation, national origin, age (18 or older), genetic information, or disability);
- (d) The complainant's signature or the signature of the complaint's authorized representative.
